According to the Organic Act on the Prevention and Suppression of Corruption B.E. ๒๕๖๑ (๒๐๑๘), Section ๑๒๘, paragraph one, prohibits any public official from receiving property or any other benefit that may be calculated as money from anyone. Other than property or legitimate interests Rules or regulations issued by virtue of the provisions of law, except for the receipt of property or other benefits by virtue of the rules and amounts prescribed by the Board of Directors. and the Code of Ethics of Police Officers B.E. ๒๕๖๔ (๒๐๒๑), Article ๒(๒) of honesty and honesty. Perform legal duties Formality of the Royal Thai Police with transparency Refrain from demonstrating behavior that implies exploitation and abuse of responsibility for human rights duties. Be ready for audit and liability And Article ๒(๔) thinks of the common good rather than personal benefit. Public spirit, cooperation, cooperation and sacrifice for the common good and create happiness for society in conjunction with the National Reform Plan on Prevention and Suppression of Corruption and Misconduct (Revised Version) Define key reform activities Activity ๔: Develop the Thai bureaucracy to be transparent and useless Goal ๑ Article ๑.๑ All government agencies shall be declared as agencies where all government officials do not accept gifts and gifts of all kinds from performing their duties (No Gift Policy).

Therefore, in order to prevent conflicts between self-interest and the common good. (Conflict of Interest) Accepting bribes, gifts, gifts, or any other benefits that affect the performance of duties. Therefore, guidelines for anti-graft practices (Anti-Bribery Policy) and not accepting gifts. Gifts or other benefits (No Gift Policy) The details are as follows:

၅. To prevent or reduce the chance of receiving bribes. Conflicts of interest in various forms to police officers under Saimai Police Station
၆. To encourage police officers under Saimai Police Station Consciousness of refusing to accept gifts and gifts of all kinds.
၇. To create a strong and sustainable corporate culture of integrity and transparency of the bureaucracy.
၈. To determine the section. Guidelines and mechanisms to prevent giving/accepting bribes or other benefits
၉. To determine guidelines for receiving fees, certifications or gifts of executives and police officers under Sai Mai Police Station in accordance with relevant regulations.
၁၀. To support and enhance the implementation of the National Strategy, the Master Plan under the National Strategy and the National Reform Plan on Prevention and Suppression of Corruption and Misconduct, as well as as be part of the guidelines for assessing the integrity and transparency in government agencies.

Scope of applicability

It applies to all police officers under Sai Mai Police Station.

article ၅ This Notice

“commander” means a person who has the authority to direct, direct, monitor. and check the police officers under the department.

"Bribe" means property or any other benefit given to a person to induce him or her to act or not act in office. Whether it is right or wrong, with duty.

"Performance" means the act or performance of duties of a public official. In a position appointed or assigned to perform a particular duty or to act on behalf of a police officer in any of the duties, both general and specific, as a police officer prescribed by law. The authority or act in accordance with the authority specified by law shall have the authority and duties of the police.

“Gifts, gifts, or any other benefits that affect the performance of duties.” means money, property, services or any other benefit of value and includes tips received by government officials in addition to salary. Income benefits from the government in normal cases and affect decision-making. approval Authorize or otherwise perform duties in a manner that favors the presenter in a corrupt manner in the past.or at the time of receipt or in the future.

Article ୭ Police officers at all levels shall conduct themselves. as follows

୭ Do not ask, lead, do not give or accept bribes, gifts, gifts or any other benefits from Performance of duties

୮ Do not consent or knowingly allow family members to give or accept bribes, gifts, gifts, or any other benefits to those involved in the performance of their duties.

୯. The performance of duties must be based on law enforcement with fairness, the interests and image of the police. Must not commit any act that conflicts between personal interests and public interests, such as accepting gifts, gifts, or any other benefits that affect the performance of duties. The use of government resources of the central government for personal benefit., Disclosure of inside information Crowding out official hours to do extra work, etc.

୧୦. Reduce the giving or receiving of property or other benefits in accordance with the rules and amounts specified by the NCC Office by using the method of expression by signing greeting cards, greeting books, condolence cards, or using social media instead of giving items.

୧୧. Won't Not resistant. Not indifferent. To the behavior of accepting bribes, gifts, gifts or other benefits from the performance of duties./The station chief will know ASAP.

Article ୧୨ The supervisor shall have the authority and duty to supervise, monitor and inspect the police officers under the department to comply with this announcement. In case of any violation of this notice, the Superintendent/Station Superintendent shall be reported as soon as possible.

article ୧୩ Anyone found to have acted in violation of this notice. Complaints/whistleblowing can be made directly through the Superintendent./Station chief at Saimai Police Station or by phone number ୦୬୬୧ ୬୬୬ ୬୦୩୧ The information of the complainant/whistleblower will be kept confidential and confidential. strictly

article ୧୪ In case of receiving complaints/clues Personnel affiliated with such offences at the police station will conduct an investigation. And if an offence is found, the person who commits such an act will be punished according to the law. and submit matters according to the order of command.

Punitive measures/violations of guidelines

୧୫. Failure to comply with this policy may result in disciplinary action or criminal or legal action.

Measures to protect complainants/whistleblowers Confidentiality, protection measures for petitioners and witnesses

One. Consideration of complaints shall establish a layer of confidentiality and protection of related parties in accordance with the regulations governing Government Confidentiality B.E. ๒๕๔๔ (๒๐๐๑) and submission of the matter to the agency for consideration.

For example, complaints accusing government officials in the first place must be treated as confidential.

If it is an information card, consider only those who provide evidence. The surrounding cases are evident, as well as pointed out.

Individual witnesses only certainly. Influencer Whistleblowing The name and address of the petitioner must be concealed. If the name and address of the

The petitioner shall notify the relevant authorities and provide protection to the petitioner as follows: "The supervisor shall exercise discretion.

Order as appropriate for the protection of the petitioner. Witnesses and persons who provide information in the investigation should not be harmed.

or unfairness that may arise from the complaint. witnessing or providing information" in case of name.

The accused must protect both the petitioner and the respondent as the matter has not gone through the process of false verification.

True, and it may be bullying, accusation, suffered and damage, and the case of the complainant stated in the word.

Request to conceal or wish to disclose the name of the complainant. The agency must not disclose the name of the petitioner to the agency.

This is because the petitioner may have suffered on the grounds of the complaint.

Livelihoods If any action is necessary, such as separation of the workplace to prevent the petitioner. Witnesses and Witnesses

Accused meet, etc. The consent of the petitioner and witnesses is required.

Three. Victim's request Petitioners or witnesses, such as requests for relocation of workplaces or methods of prevention.
